

Documents needed on an application for a National type approval

- a. A drawing showing the vehicles main measurements. If the vehicle is a M2 or M3 the drawing must show the vehicle from above and from the side, in the scale 1:20 or 1:25. It must also show passenger area, size and location of luggage compartment and doors.
- b. One photograph showing the front of the vehicle and one side, another photograph showing the rear of the vehicle and the opposite side.
- c. Instructions manual or compatible information.
- d. Information on the meaning of each symbol in the VIN number (Vehicle Identification Number) and the type code.
- e. Drawing of the brake system with detailed description on its function. If the brake system includes a load-sensing regulator, information shall be provided regarding the pressure of brake-air or brake-fluid from the regulator, according to vehicle load.
- f. Confirmation or certificate from the vehicle manufacturer stating:
 - That the vehicle full fills valid directives, regulations and standards according to table on page 2.
 - The technically permissible maximum mass on each axle and technically permissible maximum laden mass of the vehicle.
 - The technically permissible maximum mass of braked trailer and unbraked trailer.
 - The engine displacement and maximum net power.

Documents = Confirmation or affidavit from manufacturer or technical division required.- Marking =Marking of equipment required.
